Darjeeling would like to inform you that 2 mobile phones (1) Redmi having 2 sim cards being contact nos. 9434048896, 8918465848 (2) Samsung Mobile having 1 sim card being contact no. 9734148896 had been stolen from my above addressed house on last night as it was evident from my CCTV footage that an unlawful assembly held at around 3.40 AM in front of my house and from the window side of my ground floor bedroom, the said phones were stolen by the miscreants. That the very mobile numbers as installed in the said phones are too vital for me and the act held at the residents of an elected public representative shall have to be identified and investigated under priority basis.

So it is therefore requested to catch the wrong doers behind the very act as well as recover the said mobile phones along with sim cards and prosecute the wrong doers under effective penal provisions for the proper administration of Justice.
