I have been directed by the Superintendent, RMS "SG" Division, Siliguri, to inform you the following facts to lodge an FIR against the 16(sixteen) Dak Sevaks Candidates mentioned in the Annexure-I.

The 16 (sixteen) candidates were provisionally engaged as DAK SEVAK under Head Record Officer, RMS "SG" Division, Siliguri-734001 in Department of Posts, Govt. of India, since 29-06-2020. They have submitted their Madhyamik Passed mark sheets and certificates from "Board of High School and Intermediate Education, U.P."

In the procedure of verification of educational qualification certificate in respect of those candidates are found forged and fake vide this departmental enquiry reports enclosed herewith.

In this regard it is to intimate that the said Dak Sevaks have already been terminated from their engagement due to submit of Fake educational documents under this office memo. No.HRO/SG/GDS/Apptt./Pt-II dated 12.02.2022.

On the basis of the above circumstances, it is requested to lodge an FIR against the said 16(sixteen) Dak Sevaks, and submit necessary report to this office as early as possible.
