Sir,

In producing herewith one arrested accused person namely Dayal Barman (25), S/O- Haren Barman of Mirjanga, Patharghata, PO New Chumta, PS Matigara, Dist Darjeeling along with one seized vehicle bearing no- WB- 73-C-1387 (JCB Utility Vehicle) under proper seizure.

I, PSI Abhishek Theengh of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against one namely Dayal Barman (25), S/O- Haren Barman of Mirjanga, Patharghata, PO New Chumta, PS Matigara, Dist Darjeeling, the driver of Seized vehicle bearing no- WB- 73-C-1387 (JCB Utility Vehicle) to the effect that today on 18.02.2022 at 00.25 hrs received a specific source information that one vehicle bearing no- WB- 73-C-1387 (JCB Utility Vehicle) was found at Nimai Jote under Matigara PS, which was trying to load river bed materials. Accordingly I informed the matter to the O/C PS and being directed by the O/C PS I along with assisting force left PS to verify the veracity of source information. On the way towards Nimai Jote, Matigara I detained the said JCB Utility Vehicle bearing no- WB- 73-C-1387 (JCB Utility Vehicle) who was trying to load the river bed materials without the knowledge of the owner of the said JCB Utility Vehicle. on Nimai Jote Ghat, Matigara and also apprehended the driver of the said vehicle who on being asked disclosed his identity as Dayal Barman (25), S/O- Haren Barman of Mirjanga, Patharghata, PO New Chumta, PS Matigara, Dist Darjeeling)

Accordingly I seized the vehicle bearing no- WB- 73-C-1387 (JCB Utility Vehicle) and subsequently arrested the driver named Dayal Barman (25), S/O- Haren Barman of Mirjanga, Patharghata, PO New Chumta, PS Matigara, Dist Darjeeling. The whole process of seizure and arrest was made in between 01:15 hrs to 01:25 hrs.

Hence, I pray that a specific case may kindly be started against the driver Dayal Barman (25), S/O- Haren Barman of Mirjanga, Patharghata, PO New Chumta, PS Matigara, Dist Darjeeling under proper section of Law and arrange for its investigation.
