Sir,

In producing herewith four (04) arrested accused persons namely (i) Sunil Tamang (28) S/O Shankar Tamang of Debidanga, Milanmore, P.S- Pradhannagar, Dist- Darjeeling, (ii) Sany Biswas (19) S/O Lt. Mantu Biswas of Shibmandir, Lelinpur, P.S- Matigara, Dist- Darjeeling, (iii) Sonu Roy (43) S/O Narayan Roy of Guriajote, P.O- Himul, P.S- Matigara, Dist- Darjeeling, (iv) Raju Roy (19) S/O Debraj Roy of Dagapur, Bandijote, P.S- Pradhannagar, Dist.- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

(1) One iron made Crowbar measuring 26 inch (approx) in length from the possession of Sunil Tamang which was kept on his right hand,

(2) One iron made sword measuring 30 inch (approx) including wooden handle from the possession of Sany Biswas which was kept concealed on his back side,

(3) One Iron rod measuring 40 inch (approx) in length from the possession of Sonu Roy which was kept on his right hand,

(4) One Iron rod measuring 30 inch (approx) in length from the possession of Raju Roy which was kept on his right hand

I, PSI Newton Biswas of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Sunil Tamang, (ii) Sany Biswas, (iii) Sonu Roy, (iv) Raju Roy, and (v) Kalu, (vi) Manmohan and others to the effect that today on 18.02.2022 at 02.15 hrs received a sources information that 10/12 youths have assembled near Laska Bridge under Matigara PS with a view to commit docoity at Nimtala area. The fact was diarized in GDE vide Matigara PS GDE No-1207 dated 18.02.2022. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Tapan Das, C/986 Rajib Sarkar, C/1008 Kanak Roy, C/1035 Santosh Rabidas, CV/387 Sukumar Barman and CV/155 Sukumar Das left for the place to work out the information.

At about 02.55 hrs after reaching Near Laska Bridge PS- Matigara I met my source and as pointed by the source we started approaching towards the spot and cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence. But, seeing the police party approaching towards them they tried to flee away from the spot. But, on hot chase we managed to apprehend above noted five (5) accused persons namely (i) Sunil Tamang, (ii) Sany Biswas, (iii) Sonu Roy, (iv) Raju Roy along with seized articles from their possession as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity at Nimtala area. It is also revealed from them that Kalu, Manmohan and some others have assembled there with them and planned for committing the dacoity.
