Sir,

In producing here with the one accused person namely Bishal Rai (34) s/o Late Kamal Rai of Baikunthapally, Bottle Company, Ward No. 41, PS Bhaktinagar, Dist. Jalpaiguri along with following seized articles as per proper seizure list:

1] Fourteen (14) Bottles of Himalayan Gold 60 UP Country Spirit each Bottle containing 600 ml

I, ASI Dipak Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person to the effect that on 18.02.2022 at around 16.35 Hrs received a source information that the above noted accused person has possessed huge amount of Liquor at his House situated at Bottle Company under Bhaktinagar PS for the purpose of selling the same to his designed customers. This refers to BKN PS GDE No. 898, Dt. 18.02.2022. Accordingly the information shared before you and as per your kind direction I along with CVF-935 Biplab Roy and CVF-619 Dharmendra Roy of Bhaktinagar PS headed towards Bottle Company to verify the veracity of the information. At about 16.50 Hrs we reached at Bottle Company and after being identified by the source I along with my team held raid at the said House and apprehended one person. On being asked the apprehended person disclosed his identity as noted above. Further maintaining his decency and observing all formalities searched his House and recovered huge amount of above noted seized liquor. On demand he could not produce any valid documents in respect of recovered liquor. On enquiry the apprehended person admitted his guilt and confessed that he has been storing the liquor for the purpose of selling to the local customer without any valid licence or Documents for his wrongful gain. Accordingly, I seized all the recovered liquor in presence of witnesses duly signed by them as well as accused person. The seizure was made in between 17.10 hrs to 17.35 hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Bishal Rai (34) s/o Late Kamal Rai of Baikunthapally, Bottle Company, Ward No. 41, PS Bhaktinagar, Dist. Jalpaiguri under proper section of law and arrange for its investigation.
