Respected Madam,

I, Salma Begam, wife of Md. Babuddin Miya @ Babudin Miya Residence of Hochimin Nagar, Dakshin Bagdogra P.O- Bagdogra, P.S. Bagdogra, Dist: Dajeeing, do hereby states as follows:-

- ① That I got married with Md. Babuddin Miya @ Babudin Miya s/o. Late. Moshum Hanif Miya on 19.06.2006 at my father house situated at Balli Jola, P.O- Humsangaj, Dist: Sitwan, State Bihar according to Muslim law rites and Customs.
- ② That after the said marriage my husband took me in his house situated at vill and Dhatigana, P.O- Dhatigana Dist: Gopalganj, State Bihar. After the first day of our marriage my In-laws and my husband started both mental and physical torture upon me, and even cut the pipe of Gas-Cylinder to kill me. My Mother-in-law used to Induce my husband due to which my husband used to assault me by fist, blows and kicks.
- ③ That in the mean time my In-laws and my husband had several times done these types of illegal acts of assault/torture upon me and they forced me to bring money from my father's home by threatening me.

② That my husband had several times leave me alone in the said Begdagan house and resided in his paternal house that is in Bihar.

③ That I had heard from my local neighbour that my husband had got second marriage without divorced me. Local people of my neighbour had told me that my husband had got second married on 10/2/22.

Thereafter I Dispressed.

④ That on 14/2/22 some unknown miscreants with my husband had come in my house and assaulted me by all of them and also kicks and blows to my children by them and gave me last chance to leave the said house, and also they threatened me that if I will not withdraw all of the cases even I have not leave the said house they will kill me.

Therefore again on 16.2.22 my husband had come in my house and threatened me that he got second marriage and he with his second wife will reside in the said house. Hence it is my humble prayer before you that I became ready disressed and mental agony ungoing trauma and under lot of fear and lost my chastity and my reputation in the society at large.

Therefore please take necessary legal steps against my husband and unknown miscreant and punish him in accordance of law, for ends of administration of justice.
