In producing herewith 03 arrested accused persons namely 1) Santosh Kumar Gupta (41 yrs) S/O Ramji Gupta of Deshbandhuparapara near Dadavai Club, Ward No. 29, PS- Siliguri, Dist- Darjeeling, 2) Sidhartha Chakraborty (32 yrs) S/O Bidhyut Chakraborty of 1 no. Dabgram, Rajiv Gandhi Street, Ward No. 23, PS- Siliguri, Dist- Darjeeling and 3) Bhola Mandal (32 yrs) S/O late Sishu Mandal of Deshbandhupara near Indoor Stadium, Ward No. 29, PS- Siliguri, Dist- Darjeeling along with seized article vize :- i) Cash Rs. 7720/- (Seven thousand seven hundred and twenty rupees) as board money, ii) One Black color Lenevo Company Key board, iii) One black color IBALL Company Key Board, iv) One Lenovo company Laptop, v) One Asus Company Laptop, vi) 03 nos. of Counting Note Book, vii) One HP company Printer Machine having Model no. MFP-M132SNW and viii) Huge nos. of Computer Printed Coupon having Seller Raj Lotery (Rajshree Group India) where mentioned win draw date and amount having dated 11.02.22, 14.22.22, 17.02.22 and 18.02.22 as per seizure memo.

I, S.I. Uday Chakraborty of Siliguri PS, under Siliguri Metropolitan Police, do hereby lodged this written complaint against accused persons namely 1) Santosh Kumar Gupta (41 yrs) S/O Ramji Gupta of Deshbandhuparapara near Dadavai Club, Ward No. 29, PS- Siliguri, Dist- Darjeeling, 2) Sidhartha Chakraborty (32 yrs) S/O Bidhyut Chakraborty of 1 no. Dabgram, Rajiv Gandhi Street, Ward No. 23, PS- Siliguri, Dist- Darjeeling and 3) Bhola Mandal (32 yrs) S/O late Sishu Mandal of Deshbandhupara near Indoor Stadium, Ward No. 29, PS- Siliguri, Dist- Darjeeling to the effect that on 18.02.22 at 16.25 hrs, received an source information that the above noted persons are playing One Digit gambling with above noted seized articles in the house of Dipankar Chakraborty situated at Prankrishna Colony near Indoor Stadium, Ward No. 28 under Siliguri PS. I shared the information with the I.C. Siliguri PS and diarized the fact in GDE vide GDE No.977 dated 18.02.22. As per direction of I/C Siliguri P.S, I along with ASI Subir Sen, ASI Siben Sarkar, ASI Dhruba Misra, CV/283 Prosenjit Dey and CV/622 Ramanath Barman, all of Siliguri PS to work out the information after briefing my officers and force properly. On reaching at near Indoor Stadium, Siliguri at considerable distance and briefed my accompanying officers of force. On being shown by the source, we proceeded to place where the accused persons gambling with the above noted seized articles. Meanwhile, I called disinterested witness namely; i) Ratan Saha (36 yrs) S/O Manaranjan Saha of Rabindra Nagar, Ward No. 21, PS- Siliguri, Dist- Darjeeling, ii) Chandan Yadav (45 yrs) S/O Niranjana Yadav of Prankrishna Colony near Indoor Stadium, Ward No. 28, PS- Siliguri, Dist- Darjeeling and iii) Dipankar Chakraborty (48 yrs) S/O Sankar Chakraborty of Deshbandhupara near Indoor Stadium, Ward No. 29, PS- Siliguri, Dist- Darjeeling and requested them to accompany us during raid, search and seizure. I, then, along with others officers and force conducted raid in the house of Dipankar Chakraborty S/O Sankar Chakraborty situated at Deshbandhupara near Indoor

Stadium and found that the above noted persons are plying gambling with help of money and above noted seized articles for their wrongful gain and wrongful loss, searched in the place in the presence of independent witnesses and seized the above noted gambling articles in presence of witnesses as per seized. On interrogation, they disclosed their name as mentioned above. They admitted that they were gambling with the above noted seized articles clandestinely in a closed room of house of Dipankar Chakraborty causing wrongful gain to one and wrongful lost to others. The seizure and label was made in between 17.35 hrs and 19.05 hrs. Accordingly I arrested the above noted accused persons after issuing memo of arrest.

I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the above noted arrested accused persons namely 1) Santosh Kumar Gupta (41 yrs) S/O Ramji Gupta of Deshbandhuparapara near Dadavai Club, Ward No. 29, PS- Siliguri, Dist- Darjeeling, 2) Sidhartha Chakraborty (32 yrs) S/O Bidhyut Chakraborty of 1 no. Dabgram, Rajiv Gandhi Street, Ward No. 23, PS- Siliguri, Dist- Darjeeling and 3) Bhola Mandal (32 yrs) S/O late Sishu Mandal of Deshbandhupara near Indoor Stadium, Ward No. 29, PS- Siliguri, Dist- Darjeeling and arrange for its investigation.
