Respected Sir,

I, Shrabani Das, D/O. Nanda Das W/O. Abhijit Paul, of C/O. Paul Bari, Behind Mount View School, Ashraf Nagar, Ward No. 40 of SMC, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to report you the following facts:-

1. That Abhijit Paul, S/O. Ranjit Paul, of at present of C/O. Paul Bari, Behind Mount View School, Ashraf Nagar, Ward No. 40 of SMC, P.S. Bhaktinagar, Dist. Jalpaiguri is my legally married husband and we have one male child out of our said wed lock relation. Our marriage was solemnized on 28.09.2014.
2. That soon after marriage my husband started to torture me both physically and mentally for demand of dowry and my mother in-law namely Sobha Paul and my Dewar (younger brother -in-law) namely Raju Paul also used to support him in his torture and used to instigate my husband to torture upon me for dowry. They use to tell me to bring cash Rs. 1,00,000/- from my father's house and when I could not fulfill their such demand due to my father's poverty their torture upon me increased rapidly day by day. My husband in order to compel me to leave him so that he can marry with another girl and get huge and handsome amount of dowry tortured me in various ways. He used to tell that as I cannot fulfill his demand he would engage me in prostitution business and get money from there. He even forcefully made my naked videos and sent it to his friends and his said brother Raju Paul which is still saved in his phone and used to threaten me that if I do not fulfill his demands or earn money by engaging in prostitution business he would upload those naked videos in social media and when I reported the said matter to my family members then he assaulted my father, brother and my maternal uncle by saying that if they interfere in our lives then he would divorce me and thereafter, he assaulted me mercilessly on 23.11.2021 by fists and blows and hit me hard on my face by iron knuckle and stomach by helmet and hit my head on wall

and even hit hardly on my private parts and thereafter, I was treated at Siliguri Hospital and even CT Scan was done of my head and when I was going to complain about him at P.S. at that time he apologized to me and told that he would never do such thing and I thinking the future of our child condoned his fault.

But few days after that he again started to torture me and blackmail to engage in prostitution business by showing those naked videos.

3. That again today at about 11 a.m. my husband started to abuse me in filthy language s and started to physically assault me and asked me to engage in prostitution business as he is an addict and does not earn and money is needed for taking drugs. But I flatly denied to do so at that time he closed the door of our room and hit me hard on my face and scratched my neck and breast and other body parts and when I resisted he with intention to murder me poured kerosene oil on my body but anyhow I saved myself by blowing off the matchstick and cried for help and pushing him came out of the room opening the lock and then he out of rage burned down all my clothes and documents I.E. Voter Identity Card and Aadhaar Card and my all medical documents. I thereafter, informed the aforesaid facts to para people and they informed the police and police came and took him at P.S.

Had I not blew off the match stick and escaped from there my husband would have definitely killed me.

I, therefore, requested you to kindly take necessary legal action in the aforesaid matter against the aforesaid culprits.
