With due respect I, Smt. Rinku Saha, Wife of Sri Khokan Saha, resident of Fokdoibari near Child Welfare, P.O. Ghogomali, P.S. Bhaktinagar under Ashighar Outpost, District Jalpaiguri beg to inform you that on 19.02.2022 at about 9 P.M. my husband Sri Khokan Saha had been coming from my daughter house and when he reached in front of Bura Buri Mandir, Eastern Bypass, P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri one **Motor Cycle (Yamaha), bearing No. WB-74BF0729** (owner of the vehicle Sri Subhankar Sarkar) with three riders coming from Ashighar side towards Jaleshwari Bazar with high speed hit the cycle of my husband. Due to said accident my husband received serious injury in his whole body, left leg has been fractured and also received grievous injury in head. Immediately the local people rushed the spot and taken away my husband at Siliguri Sadar Hospital and admitted him but the Doctors of Siliguri Hospital seeing the injury immediately sent him at North Bengal Medical College & Hospital and now he is under treatment of Doctors of North Bengal Medical College and Hospital. The said accident took place due to rash and negligent driving of the Motor cycle Rider.

You are therefore, request to inquire into the matter and take necessary action and oblige.
