Sir,

With due respect, I am producing herewith one arrested accused person namely Rajib Laskar (22 yrs) S/O Gopal Laskar of Fulbari, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 34 (Thirty four) numbers paper made Cartoon Containing 24 bottles in each cartoon i.e. total 816 (Eighty hundred sixteen) bottles of Mc Dowell's No-1 Premium Whisky. Each bottle containing 375 ML.
2. 12 (Twelve) numbers paper made Cartoon Containing 24 bottles in each cartoon i.e. total 288 (Two hundred eighty eight) bottles of Royal Stag Premiur Whisky. Each bottle containing 375 ML.

I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 21.02.22 at 13.55 hrs I received a secret source information that one person namely Rajib Laskar of Fulbari, PS- NJP, Dist.- Jalpaiguri store huge quantity of illegal I/D liquor with a view to deliver the same to Bihar. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No-779 dated 21.02.22 and informed the fact to you. As per your kind direction and instruction myself along with ASI Sajal Das, ASI Khagen Barman, C/1053 Paresh Rava, VP/08 Laxman Roy, VP/13 Jamirul Islam, CV/306 Biswajit Roy and others all of NJP PS, SPC left for Fulbari to work out the information in hand. At about 14.25 hrs we arrived at Fulbari and being identified by the source I managed to apprehended one person who disclosed his identity as noted above. During interrogation he confessed that he stored illegal I/D liquor at his residence with a view to deliver the same to Bihar for his illegal gain. As per his leading statement, I held raid at his residence and recovered the above noted I/D liquor from his residence. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his possession. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 15.05 to 16.55 hrs on 21.02.22.


Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Rajib Laskar (22 yrs) S/O Gopal Laskar of Fulbari, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.


