In producing herewith three arrested accused persons namely i) Gobinda Kumar Mandal (M/40) S/O Late Ganga Prasad Mandal of Vill- Pirhali, PS- Kalinagar, Dist- Darbhanga, Bihar A/P Tenant of Gopal Sarkar of Mahananda Para, Chandra Park, Behind Modern Boys Club, Ward No. 4, PS- Siliguri, Dist- Darjeeling, ii) Ranjan Sarkar S/O Late Manindra Ch. Sarkar of Sashtri Nagar, near Bal Krishna Sangha, Ward No. 41, PS- Bhaktinagar, Dist- Jalpaiguri and (iii) Runu Sarkar (M/35) S/O Gopal Sarkar of Mahananda Para, Chandra Park, Behind Modern Boys Club, Ward No. 4, PS- Siliguri, Dist- Darjeeling, along with seized articles as follows;

i) 95 Cartoons of **ETHCOREX-CD** Cough Syrup containing 100 bottles each. Each bottle contains 100 ml which contains mixture of 10 mg Codeine Phosphate & Chlopheniramine Maleate syrup 4mg, having batch No. TBHV0185 Manufactured by Three B Health Care Ltd (Total 95 X 100 =9500 Bottles) Each bottle MRP RS. 165/- and marked as Exhibit-A out of which one cartoon randomly taken as sample & marked as Exhibit-A-1.

ii) 04 Cartoons of **ONEREEX** Cough Syrup containing 144 bottles each. Each bottle contains 100 ml which contains mixture of 10mg Codeine Phosphate & Chlopheniramine Maleate syrup 4mg, having batch No. 191121-SD28 Manufactured by Smilax Health care Pvt Ltd. (Total 04 X 144 = 576 Bottles) Each bottle MRP RS. 144.50/- and marked as Exhibit- B, out of which one cartoon randomly taken as sample marked as Exhibit-B-1.

iii) 18 cartoons of **Nitrazone-10 tablet**, Batch no-WNZ19001 Manufactured by Windlas Biotech Pvt. Ltd, containing 180 small box each box containing 10 strips of 10 Tablets , Total =18 X 180 X 10 X 10 = 324000 Tablets Each Strips MRP RS. 45/- and marked as Exhibit- C, out of which one cartoon randomly taken as sample & marked as Exhibit-C-1.

iv) 18 cartoons of **SPASCORE-VON PLUS capsules**, Batch no-AC1677 Manufactured by Aligon Pharmaceuticals Ltd, containing 105 small box each box containing 6 strips of 24 capsules , Total =18 X 105 X 6 X 24 = 272160 Capsules Each Strips MRP RS. 204/- marked as Exhibit-D and out of which one cartoon randomly taken as sample marked as Exhibit-D-1.

v) 02 cartoons of **Winspasm Forte Capsules**, Batch no-WPS 21017 Manufactured by Windlas Biotech Pvt Ltd, containing 120 small box of 6 strips of 24 capsules , Total = 02 X 120 X 6 X 24 = 34560 Capsules Each Strips MRP RS. 56/- and marked as Exhibit-E and out of which one cartoon randomly taken as sample marked as Exhibit-E-1.

I SI Biswajit Ghosh of Detective Department, SPC, Siliguri lodge a written complaint to the effect that on 19.02.2022 at 12.05 hrs received a reliable source information that the above noted accused persons are storing cough syrup, tablets and Capsules at a godown of Gopal Sarkar S/O Late Haralal Sarkar of Mahananda Para, Chandra Park, Behind Modern Boys Club, Ward No. 4, PS- Siliguri, Dist- Darjeeling for selling to the drug addicts at higher prices without prescriptions for their wrongful gain. I diarized the same vide DD,SPC GDE No. 71 Dt: 19.02.2022 and informed ACP, DD, SPC. Accordingly on his consent myself along with SI Rash Bihari Saha, ASI Binod Jha, C/166 Gopal saha, C/126 Satrugan Sen of SOG, SPC and SI Tamjit Ali, ASI Proloy Bhattacharjee, ASI Abu Taleb, C/371 Sushanta Dey, C/813 Gyanendra Ch Sarkar of DD SPC left for Mahananda Para, Chandra Park, Behind Modern Boys Club, Ward No. 4, PS- Siliguri, Dist- Darjeeling vide DD,SPC GDE No 72 Dt: 19.02.2022 and CC No 31/22 Dt: 19.02.2022 to work out the information. At the time of departure from the office, I took envelope, white paper, sealing wax, gum, seal, official stamp, stamp pad and all necessary requirements.

At about 12.30 hrs, we arrived at said godown as indicated by the source and in presence of local witnesses namely (1) Rajesh Das (36) S/O Late Bhabani Das of Mahananda Para, Chandra Park, Behind Modern Boys Club, Ward No. 4, PS- Siliguri, Dist- Darjeeling (2) Biswajit Poddar (55) S/O Shyam Sundar Poddar of do (3) Mriganka Dutta (30) S/O Malay Dutta of do, entered there and found the above mentioned three persons were arranging several cartoons which were supposed to be taken out of the godown. On being asked being asked they disclosed their names as above. On being asked to justify about their presence in the said godown with those packed cartoons, they could not give any satisfactory answer and confessed that those packed articles were drugs which were obtained fraudulently from somewhere with intension to sell at Siliguri and surrounding areas illegally for their wrongful gain. On demand they failed to produce any documents to support the possession of said drugs.

We then detained them and asked them whether they wanted to be searched in presence of Executive Magistrate or Gazetted Officer and they agreed to be searched by any one of them. Then I called Sri Suraj Thakuri, ACP (HQ), SPC as a Special Executive Magistrate to attend at the spot for search and seizure. At 13.05 hrs Sri Suraj Thakuri, ACP (HQ), SPC appeared at the spot and gave the identity as executive magistrate before detained persons. Then I searched the godown and found (1) 95 Cartoons of ETHCOREX-CD Cough Syrup containing 100 bottles each. Each bottle Contains 100 ml (2) 04 Cartoons of ONEREEX Cough Syrup containing 144 bottles each. Each bottle contains 100 ml (3) 18 cartoons of Nitrazone-10 tablet, containing 180 small box each box containing 10 strips of 10 Tablets, (4) 18 cartoons of SPASCORE-VON PLUS capsules, containing 105 small box each box containing 6 strips of 24 capsules, (5) 02 cartoons of Winspasma Forte Capsules, containing 120 small box of 6 strips of 24 capsules.

It is seen that all the articles found as mentioned above are prescription drugs which falls under NDPS Act and liable for punishment as per its provision. I seized all the above articles along with other articles as mentioned above in separate and proper seizure list in presence of the witnesses who were accompanying us with proper sealing and labeling which was seized from the joint possession of the above mentioned accused persons. The articles seized are psychotropic substance which is used by the Drug abusers for intoxication. Hence having strong reason to believe that they were committing the offence under NDPS Act I, arrested them by preparing arrest memo and took them under my custody. The seizure was made in between 13.15 hrs and 17.35 hrs. On further interrogation they also confessed they along with few others are running this business illegally.

All the accused persons have committed the offence under NDPS Act and liable for punishments as per its provision.

Hence a specific case may kindly be started against the above mentioned arrested accused persons and others and arrange for its investigation.
