Subject: physically harassment, torturing for dowry, outrage of modesty and dire consequences of death

Dear Madam,

I, Ruby Gupta w/o Yogendra Nath Gupta is continuously getting harassed by my first brother in law- Dharmender Nath. Since my marriage was arranged with Shri Yogendra Nath Gupta in 2014, Dharmender Nath Started demanding dowry and other valuables from my brothers and my mother else he will break the marriage.

I was the first choice as bride by my mother in law, my second brother in law and my husband jointly and they said yes for the marriage after our first meeting at Siliguri in 2014. But when Dharmender Nath came to our home at Darjeeling in January 2015 to meet our family, he demanded 20 lakhs cash and one car or else he will not allow his elder brother to marry me. He started putting pressure on my brothers to arrange the amount before my engagement which was planned on 25-01-2015.

My brothers informed my husband about the problems created by Dharmender Nath. My husband is very simple, down to earth and helping in nature, he asked Dharmender not to demand anything from my family and asked not to create unnecessary drama. On engagement day i.e. on 25-01-2015, Dharmender Nath misbehaved with our relatives came for the engagement function at Siliguri and also misbehaved with my brothers, sister in law and sister. He uttered bad comments like- " Bhikhario ki lautary lag gayi, aisa itna acha ladka free me mil gaya ". Our family avoided his words as they were very happy to have a good family and husband for their daughter.

Later when marriage date was finalized on 30-05-2015, Dharmender again called my brother and demanded dowry or else he will object for the marriage. He also insisted my brothers to arrange marriage at Siliguri instead of Darjeeling. My family is permanent resident of Darjeeling but still compromised and started preparation of marriage at Siliguri.

Dharmender Nath was also commenting about our arrangements of engagement and warned my brothers that arrangements for the marriage should be a kind of grand celebration and arrangements should be of five star categories. My brothers were afraid of misbehavior and drama. My brothers arranged the best they can afford and informed Dharmender Nath to have a look of their arrangements.

Dharmender Nath again when visited the marriage hall and listening about arrangements he mistreated my brothers. But still my brothers said nothing to him and assured him that there will be no inconvenience regarding arrangements.
