
Respected Sir,

With due respect and humble submission that I SI(UB) Mrityunjoy Roy of NJP T/G under SPC, ledge a written complain to the effect that on today i.e. 23.02.2022 at about 11.35 hrs one truck heaving Regd. No- WB73C3842 loaded with 17(Seventeen) Nos of barrels. During my checking duty I along with C/1059 Karlus Oraon detain the vehicle. I examined the documents of the said vehicle in presence of I/C NJP T/G Sri Santa Shil. After examine the documents on mparivahan it could be learned that all documents are found failed except PUC. The driver of the truck failed to produced his driving license and other related documents. Driver of the truck namely Esant Rai, S/O Sri Hem Kumar Rai, of Near Rly workshop, PO- Tindharia, PS- Kurseong, Dist- Darjeeling try to assault me and I/C NJP T/G and also destruct to discharge Govt. duty in presence of Biplab Biswas (9800073923), Dinesh Singh and Lanka Rajak. He also used filthy langue's with dire consequence. One employee of Rly namely Tendup Sherpa, S/O Lt. Nim Tenjing Sherpa, of Dilaram, PO- Tung, PS- Kurseong, Dist- Darjeeling was present there. As such I called the van of NJP PS. and handed over the truck with driver and 17 Nos of Barrels to start a specific case under proper section of law.
