Complaint about threats calls and text messages receiving from the phone

numbers viz. 8348180406, 7501747120& 8159947715

Respected Sir,

I, KarthikShanmugam, son of Shanmugam, working for gain at Hotel Sarovar, 3<sup>rd</sup> Mile, Sevoke Road, Siliguri - 734008, West Bengal and also being the authorised signatory of Future Gaming and Hotel Services Pvt. Ltd. (hereinafter referred as "the said company"), being the owner of the Hotel Sarovar, beg to inform you that I along with other employees of the said company have been receiving threatening calls from various phone numbers viz. 8348180406, 7501747120. That I along with other employees of the said company namely Mr. Martin the Chairman of the said company (M. No. 9843063977), Mr. BilashKhatiwada (M. No. 9953121714, Landline No. 011-45530382), Mr. Gireesh Kumar ThickalRayaroth (M. No. 8101027008), Mr. Ujjal Das (M. No. 9775477701), been receiving these calls since 05.01.2022. Off-late we have been receiving the calls and text messages from the said number even late at night, at 11:45 pm, and the screenshot of the call logs and text messages are enclosed herewith for your ready reference. And this continuous threat calls and text messagesare making us very concerned now.

That on and about 11.01.2022 the unknown callers asked us to visit Hotel Ganpati at Bidhan Road, Near MaaBhawani Kali Mandir, Siliguri, Ward No. 12, Hakimpara, West Bengal – 734001, and pay them a sum of Rs.15 Lakhs, failing which they threaten to

harm the employees and their family members of the said company. And being compelled with such threat and continuous notorious activities around Hotel Sarovar we were bound to pay a sum of Rs.15 Lakhs to the said unknown callers, who while collecting the said money kept their faces covered and voice distorted.

Thereafter again on and from 15.02.2022 they started the threat calls and text messages to the above mentioned persons for further extorting money from the said company, by way of threatening the employees of the said company over phone call and though text messages.

That after the fore stated incident we on 19.02.2022 initiated a General Diary vide No. 950 dated 19.02.2022 with the Bhaktinagar Police Station to keep the incident recorded officially.

I shall be highly obliged for your kind support and would graciously be pleased if you can initiate the case under section 383, 385, 386, 387, 388, 389, 503, 504, 505, 507 of the Indian Penal Code, 1860.

This is to request you to kindly look into the matter and take appropriate action, immediately and kindly treat this letter as FIR.
