Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, to the effect that my daughter, ^{aged 22 yrs} had/had been staying in her maternal uncle's house at Bhabasindu Colony, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri and on 20-02-2022 at about 11:00 AM, she left her maternal uncle's house in order to go to her house at the above mentioned address but she did not returned to her house and as such I along with my family members called her to know her whereabouts but found her mobile phone switched off and thereafter we searched her at every possible place but could not trace her whereabouts and finding no other alternative, I lodged a missing diary with the I/C, Bhaktinagar Police Station, Dist. Jalpaiguri vide Bhaktinagar P.S. G.D. Entry No.1087/2022, dated- 23-02-2022.

Thereafter, at about 4:30 PM on 23-02-2022 my daughter called me by her mobile number 9593788693 over my mobile phone and told me crying that said Bidhan Roy with the conspiracy and abetment of said Mojen Roy, Srimati Roy and Bappa Roy kidnapped her for the purpose of trafficking her and she has been confined by said Bidhan Roy in a room at Bangalore and she asked me for help to rescue her from him at an earliest.
