Sir,

In producing herewith one accused person namely Adip Pradhan-37yrs s/o Tek Bahadur Pradhan of Singbelli, Mirik, Dist Darjeeling at present C/o Pradhan Tea stall, Sevoke road, Near Marowari Bhawan, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 16 (sixteen) no's of pet Bottles of Himalayan Gold 60up country spirit (each bottle containing 600 ML) which was packed in one big nylon bag.

I beg to report that I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Adip Pradhan to the effect that on 24.02.22 at 19.15 hrs received a source information from Sevoke road near Marowari Bhawan under Bhaktinagar PS that one person namely Adip Pradhan has gathered huge quantity of liquor in his shop at Sevoke road near Marowari Bhawan under Bhaktinagar PS for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No- 1168 dated 24.02.22. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 19.35 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 19.45 hrs to 20.20hrs)

I therefore request you a specific case may kindly be started against the accused person namely Adip Pradhan-37yrs s/o Tek Bahadur Pradhan of Singbelli, Mirik, Dist Darjeeling at present C/o Pradhan Tea stall, Sevoke road, Near Marowari Bhawan, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation.
