Respected Sir,

I Samir Kumar Basak, 3/0 Wt. Hare Krishna Basak, resident of P.C. Sarkar Sarani, #54, Hakimpara, P.S. Siliguri, Distt:- Darjeeling begs to report you the following fact:-

- ① That I am a old and weak old man of 72 years and retired from government service i.e. (Police of West Bengal)
- ② That I have a wife namely Rupali Basak and 2 (two) married daughters, 1 (one) married son and a daughter in-law namely Swarup Basak and Riya Naylick Basak respectively.
- ③ That while I was in service, I had a very happy and loving family but as soon as I got retired in the year 2009 everything changed everyone seems to be changed, as if I was a waste product in my house.

④ That soon after my retirement, I started adjusting with everyone in my family, my wife use to pick up quarrel at every small small incident and used to instigate my son and daughter in-law and with such instigation my son Suroop Basak and his wife Riya Moullick Basak and my wife together use to abuse me in filthy languages and use to also abuse me physically and use to torture me both mentally and physically in the past years but I did not raise any voice thinking of my reputation and my family's reputation.

⑤ That yesterday i.e. 21/02/2022 at around 2:30 PM to 3:00 PM in the afternoon my wife Rupali Basak picked up quarrel for a simple reason as to why am I asking her so many questions and thereafter she started abusing me and threatening that she would call the son and the daughter in-law and will make me learn a lesson I will remember for my life. In the mean time my wife called my son and called him and his wife and instigated both of them against me

and over the phone my son started
threatening me that "Ami Siligoni er
chale ami dakhachi toke" and after few
minutes my son and his wife reached
my place and asked me to sit and
while talking he became very furious
and angry as to why I question his
mother's name and then suddenly he
stood up and gave a punch on my
left side face because of which I
received severe injuries and even my
daughter-in-law and my wife collectively
started beating me with fist and
blows and in order to save myself
from all the 3 of them I started
running towards the main gate to
scream for help from the neighbour
but they caught hold of me and
confined me by using force and
my son and daughter-in-law
entered my house without my
permission and forcefully and they
also broke the camera which was
installed in my house and they
also took the DVR of the camera
and other precious articles worth
not yet known to me fully and
also broke all the showpan and

other article and both my son and daughter in-law took huge articles 2 (two) bags full.

I am in a huge trauma and shock as to after upbringing my son and looking after my wife they did this to me my son and his wife has threatened me for the further they had even locked me in to a room in my house because of which I could not lodge a F.I.R in due time.
