My firm M/s NORTH EASTERN ENTERPRISE, Siliguri is a MSME Enterprise registered with Central Medical Stores, Department of Health & Family welfare, the Government of West Bengal as well as other Government Institutions, situated at 31/1/21 Sisir Bhaduri Sarani, Khudirampally, Siliguri, P.O. & P.S. Siliguri, District-Darjeeling (west Bengal) and a Branch at P-234 CIT Road, P.O. & P.S. Beliaghata, Kolkata-700020.

Mr Tapash Kumar Chandra is hereby referred to as Mr Chandra, the Proprietor of M/s C D Distributors of 23 G.T.Road South, Room No.G-5, Howrah-711102 possessing a godown at 31+32 Lokenath Chatterjee Lane, Shibpur, Howrah, residing at 23/1/1 Kali Kumar Mukherjee Lane, Shibpur, Howrah-711102, Contact No: (+91) 8617263516; Email ID-distributored@gmail.com

Mr Chandra's wife Mrs Subhra Chandra hereby referred to as Mrs Chandra and son-in-law Mr Mriganka Paul hereby referred to as Mr Paul, have been looking over the business of M/s C D Distributors.

In March, 2021 an order of surgical goods from my firm(in Siliguri, West Bengal)was placed. On the basis of the said order Mr Chandra raised Tax Invoices for institutions as well as for trade

and Government supply A full advance payment was made by me through NEFT as per the demand. Mr Chandra and Mr.Paul had promised to supply all the goods mentioned in their bills within 14.04.2021. Following are the details of the said bills and amount paid:-

Despite of the fact that, the payments of the bills were made in advance, but no goods were supplied by Mr. Chandra till date. Nevertheless, I tried to contact Mr Chandra but not only his cell phone was constantly unreachable, but also the mails remained unanswered. On deputing my office staff to inquire about his whereabouts, I came to know that he was nowhere to be found (neither in the office nor in the godown or in his residence).

On contacting Mrs. Chandra, no.(+91) 98740-35339 and Mr Paul,no.(+91) 92679-19470 in absence of Mr Chandra, they assured several times to disburse our stocks at the earliest opportunity. However, on several occasions, when my staff reached at the designated location to collect stocks as intimated by Mrs Chandra and Mr Paul, they found that the shop and godown of the said C D Distributors were closed and the concerned people were unavailable.

Later it came to my knowledge that Mrs Chandra and Mr Paul have handed over a significant quantity of stocks to the companies viz Smith & Nephew Healthcare Pvt Ltd(B-501-509, Dynasty

Business Park, Andheri kurla Road, Andheri (East), Mumbai-400059) through its representative Sri Debdutta Bhattacharjee no. (+91) 9836670978 and 3M India Limited(Plot No.60-61, Udyog Vihar, Phase IV, Gurgaon-122015)through its representative Sri Koushik Mondol no.(+91) 8444081030 As a result the money which I paid in advance was in vain. Besides, there have been numerous occasions where Sri Debdutta Bhattacharjee and Sri Koushik Mondol insisted me to collect stocks only from C D Distributors even when North Eastern Enterprise has a distributorship agreement with the respected company itself.

The entire payment made to C D Distributors amounting to Rs. 18,09,260/- (Rupees Eighteen Lakh Nine Thousand Two Hundred Sixty) was paid as per assurance and promise of the said people while they dishonestly misappropriated the entire amount for their own purposes and committed the offense of criminal breach of trust.

I therefore, request you to kindly take necessary legal steps against the said Mr Chandra, Mrs. Chandra and Mr.Paul, resident of 23/1/1 Kali Kumar Mukherjee Lane, Shibpur, Howrah-711102 and Mr Debdutta Bhattacharjee(debdutta.bhattacharjee@smith-nephew.com) of M/s Smith & Nephew Healthcare Pvt Ltd and Mr Koushik Mondol(kmondal@mmm.com) of
