Jalpalguri and(ii) Sourav Roy (20) S/O Krishna Roy of Do, who said they were coming junction side and informed them about the information in hand and requested them to accompany us to witness for search and seizure, if necessary in writing and to which they agreed by signing in the notice. At about 22,35 hrs myself along with ASI Rabin Lama and force reached at Sahid Nagar More, NH 10 and kept Govt. Vehicle at considerable distance and started keeping eye towards Champasari more side and after sometimes, in consonance of source input, saw three persons coming from Champasari More side and we could apprehend them and disclosed our identity. On being asked to them they disclosed their identity as noted above. I Informed them about the information in hand. At first they denied of possessing any drugs but on further grilling jointly and also separately, all three of them admitted that they were on the way to Bhaktinagar Check Post side for delivery of Brown Sugar to the customers of Salugara side and stated that the Brown Sugar was being carried by Shekhawat Biswas and all three of them came out for pedaling the same. After their admission, I gave them option notice that whether they wanted to be searched in presence of an Executive Magistrate or Gazetted officer and they agreed to be searched in presence of any Gazetted Officer. I served them a notice in accordance with the provisions of law in this regard and they gave in writing, their willingness to be searched in presence of any of them. Then, I requested Shri Amaresh Singh, Inspector In charge, Bhaktinagar Police Station, SPC over R.T to appear at the spot and remain present as gazetted officer. After some times at about 22.45 hrs Shri Amaresh Singh, Inspector In Charge, Bhaktinager Police Station, SPC arrived at the spot. I narrated the whole fact to him disclosed the identity of Shri Amaresh Singh, Inspector In charge, Bhaktinagar Police Station, SPC to the accused persons as gazetted officer. Under supervision of Shri Amaresh Singh, Inspector In charge Bhaktinagar Police Station, SPC the above noted accused persons were searched keeping strict regard of their decency and recovered One Blue coloured carry bag in which six (06) transparent plastic packets said to be containing Brown Sugar, marked as Exhibits - "A" to "F" which was kept in the left chest pocket of Jacket Shekhawat Biswas. On interrogation, they admitted that they had been carrying out their business of supplying brown sugar using their phones. They confessed in presence of Gazetted Officer and witnesses that they procured the said Brown Sugar clandestinely for the purpose of selling with a view to earn nuge money quickly. On interrogation they further confessed in presence of Gazetted Officer and other witnesses that they along with their associates had been selling the drugs procuring from Malda side. Being asked they failed to produce any documents or license in support of their such possession. Then under the supervision of Shri Amaresh Singh, Inspector In charge Bhaktinagar Police Station, SPC I weighed the said six transperant plastic packets of said to be Brown Sugar with weighing instrument which was kept with us and found the weight of recovered Brown Sugar packets as noted above, total weight 0.593 grms Grams . Then I packed, labeled and sealed the six numbers of recovered Brown Sugar packets contained in blue bag (Carry) & mobile phones in presence of witnesses, and seized all the recovered articles under proper seizure list under the supervision of Shri Amaresh Singh, Inspector In charge Bhaktinagar Police Station, SPC duly signed by the local witnesses and the accused persons. The seizure was made in between 00.05 hrs to 00:50 hrs. Then, I arrested the above noted accused persons after observing all formalities of arrest as well as after disclosing the cause of arrest and issued necessary memo of arrest. The copy of seizure list and memo of arrest have been supplied to the above noted accused person under receipt. Thus the accused persons violated the terms and condition of N.D.P.S Act. for possessing Brown Sugar without any authority.

Under the above circumstances, I pray to you that a specific case under NDPS Act may kindly be started against the accused person namely ((1) Abdul Majid (24) S/O Sukru Momin of Khaltipur, Momin Para, PS Kaliachak, Dist. Malda, (2) Ashim Akram (20) S/O Md. Alam of Bhagalpur, Nawda Jodupur, PS Kaliachak, Dist. Malda and (3) Shekhawat Biswas (27) S/O Kaimuddin Biswas of Srirampur, PS Kaliachak, Dist.
