I, ASI Rabin Lama of Bhaktinagar PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 26.02.2022 at 22.15 hrs received a source information from Prodhan para that one Anil Chandra Barman have storing huge quantity of i.c liquor and selling the same to the local customer illegally in his shop at Pradhan Para near Micro plywood company private ltd, ward no 42 PS- Bhaktinagar Dist-Jalpaiguri and selling the same in the open market to his design customer for his wrongful gain. This refers to Bhaktinagar PS GDE No- 1281dated 26.02.2022. 1 informed I/C Bhaktinagar PS about the information. As per his kind instruction I along with, CV 619 Dharmendra Roy and CV 614 Sumit kumar Roy proceeded to Prodhan para to verify and veracity of the information. At 22.30 hrs I along with my accompanied force reached at the spot, and being identified by the source I held raid in the shop of the above noted accused persons and after searching I recovered the same viz i.e Sixteen (16) Bottles of 60 UP Himalayan Gold Country Spirit (each bottle containing 600 ML), on demand he could not produce any valid license/documents in the support of said liquor. On interrogation he admitted his guilt before us and stated that he sells the same to the customer since long for his wrongful gain. Accordingly I seized the same from the possession of Anil Chandra Barman (42) after preparing proper seizure list in presence of witnesses duly sign by the accused person as well as witnesses. The seizure was made between 22.45 hrs to 23.05 hrs. Then I arrested him u/s'41 Cr.P.C. and issued Memo of arrest and appraising him the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely Anil Chandra Barman (42) S/O Late Mahendra Nath Barman of Pradhan Para near Micro plywood company private ltd, Pipeline, w/no 42 PS- Bhaktinagar Dist-Jalpaiguri under proper section of law.
