Singha of Adhikary, PS-Kharibari, Dist- DJG, (iii) Joydeb Adhikary (32), S/O Lt. Mahadev Adhikary of Rabindra Sarani, PS-MTG, Dist- DJG arrested u/s 41 Cr.P.C.

I, SI Agen Lepcha of Matigara PS SPC to the effect that on 26.02.2022 while performing SPL Mobile duty under Matigara PS area found Three persons namely (i) Bikram Barman (23), S/O Digen Barman of Kestopur, PS- BDR, Dist- DJG, (ii) Jatin Singha (35), S/O Girish Ch. Singha of Adhikary, PS-Kharibari, Dist- DJG, (iii) Joydeb Adhikary (32), S/O Lt. Mahadev Adhikary of Rabindra Sarani, PS-MTG, Dist- DJG were loitering near City Centre under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt.
