Sir,
With due respect, I am producing herewith one arrested accused person namely **Banamohan Roy(61Years) @ Puchu Roy S/O- Lt.Satish Chandra Roy of Ghoramore, Nawapara, PS- NJP, Dist- Jalpaiguri** under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 20 (Twenty) bottles of 60 Up Himalayan Gold Country Spirit containing 600 MI in each bottle.
2. 05 (Five) Bottles of ROYAL STAGE Premier Whisky containing 375MI in each bottle.

I, ASI Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 26.02.22 at 18.05 hrs I received a secret source information that one person namely **Banamohan Roy(61Years) @ Puchu Roy S/O- Lt.Satish Chandra Roy of Ghoramore, Nawapara, PS- NJP, Dist- Jalpaiguri** is selling ID liquor illegally at his house situated at Ghoramore, Nawapara, NJP. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 1021 dated 26.02.22 and informed the fact to you. As per your kind direction and instruction myself along with CV/824 Niru Kr Yadav and CV/116 Rohit Kr Mahato, CV/306 Biswajit Roy and others all of NJP PS, SPC left for Ghoramore, Nawapara, NJP to work out the information in hand. At about 18.35 hrs we arrived at his hose of accused **Banamohan Roy(61Years) @ Puchu Roy S/O- Lt.Satish Chandra Roy of Ghoramore, Nawapara, PS- NJP, Dist- Jalpaiguri** and being identified by the source I held rald at the said house and managed to apprehended the owner of the said house. On being asked he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor at his house since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 18.40 hrs 19.20 hrs on 26.02.22.


Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely **Banamohan Roy(61Years) @ Puchu Roy S/O- Lt.Satish Chandra Roy of Ghoramore, Nawapara, PS- NJP, Dist- Jalpaiguri** and arrange for its investigation.
