Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 1064 dated 27.02.22 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, C/1053 Paresh Rava, CV/306 Biswajit Roy CV/824 Niru Kr Yadav, CV/116 Rohit Kr Mahato and CV/306 Biswajit Roy and others all of NJP PS, SPC left for Samsan Busty, PS- NJP NJP to work out the information in hand. At about 18.30 hrs we arrived at his house of accused Rahul Pawan (21 yrs) S/O Paban Paswan of Samsan Busty, PS- NJP, Dist- Jalpaiguri and being identified by the source I held rald at the said house and managed to apprehended the owner of the said house. On being asked he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor at his residence since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his residence. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 18.40 hrs 19.30 hrs on 27.02.22.
