In producing herewith one accused person namely Jiten Roy (48yrs) S/o. Dondhi Roy of Bholamore, Jamurivita PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri along with the following seized articles as per proper seizure list:


1. Twenty Nine (29) Bottles of 60 UP pet Himalayan Gold Country Sprit each bottle containing 600 ML.

I, ASI. Uday Sankar Bhattacharjee of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 27.02.2022 at 18:25hrs received a source information from Sahudangi Bazar that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE 889 dated 27.02.22. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) C-975 Swarup Basak (2) CV/001 Jaychand Roy (3) CV-340 Susen Biswas and (4) VP-14 Paritosh Roy all of Ambari-Falakata OP, Under NJP PS/SPC proceed to Sahudangi Bazar to work out the information. At 18:35 hrs we reached at the spot. sometimes after being identified by the source our police party held raid at Sahudangi Bazar and recovered the above noted articles from the possession of accused person namely Jiten Roy (48yrs) S/o. Dondhi Roy of Bholamore, Jamurivita PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Abhijit Majumder S/o. Lt. Ashim Majumder of Chakiavita, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Subash Sarkar S/o. Lt. Narayan Sarkar of Ambari Falakata, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 18.45 nrs to 19:10 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Jiten Roy (48yrs) S/o. Dondhi Roy of Bholamore, Jamurivita PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri under proper section of law.




