Darjeeling, beg to inform you that on dt. 27-02-2022 at about 12:40 noon, when I parked my car bearing Regd. No. WB-74-9983, in front of my house at above noted address at that time, my relatives & neighbours namely (1) Vikash Sharma s/o Sri Gopal Sharma (2) Smt. Anjana Sharma w/o Sri Vikash Sharma (3) Smt. Sumita Sharma @ Santara w/o Sri Gopal Sharma & (4) Bijay Sharma s/o Sri Gopal Sharma, all are above noted address, stated abusing me in filthy language and when my family members namely (1) Smt. Purnima Sharma (48) w/o Sri Pramode Sharma (2) Smt. Puja Sharma (25) w/o Sri Sudeep Bhopel (3) Smt. Pinki Sharma (20) w/o Sri Pradyot Bohra, all of above noted address, protested, they broken the glass of front of my said vehicle and physically assaulted me, my wife & my daughters noted above; my wife Smt. Purnima Sharma & I received severe injury on our persons & we both immediately shifted to Siliguri Distt Hospital & treated ourselves there.
