Sir,

In producing herewith the following seized articles Viz :

1) Eight(08) Plastic made bottle of HIMALAYAN GOLD 60° UP COUNTRY SPIRIT. Each bottle contain 600 ML, marked MRP - 120/- without any valid document which was seized from the house of Santa Mahato (M/55) S/O. Lt. Anjan Mahato of Government Saw Mill Road, Ward No. 04, PS. SLG Dist.

In this regard I, ASI. Uttam Kr Dhar of Khalpara TOP PS. SLG, SPC do hereby lodge this complaint against the absconded accused person named Santa Mahato (M/55) S/O. Lt. Anjan Mahato of Government Saw Mill Road, Ward No. 04, PS. SLG Dist. to the effect that on 27/02/22 at 20.55 hrs during my Patrolling Van duty Vide GDE No.630 Dt. 27/02/2022, I received a source information that one person namely Santa Mahato has been selling illegal liquor in his house at Government Saw Mill area Ward No. 04 PS. SLG Dist. DJG. There was a further complaint that due to sale of liquor the peaceful environment of the locality has been deteriorated and it is very difficult for local people to live due to antisocial activities of the drinkers, who take drinks in the house of the accused person. Subsequently, I along with force reached at Government Saw Mill road and as showing by the source I conducted raid at the house of the accused person and on being search found the above noted articles kept in his house without any valid permission or licence and was selling the same. On seeing the Police the house owner Santa Mahato (M/55) S/O. Lt. Anjan Mahato of Government Saw Mill Road, Ward No. 04, PS. SLG Dist. Escaped from the place, I demanded the papers or license, Cash memo of the said liquor, but no one could not able to produce any legal documents in support of possession of above noted spirit. On 27/02/2022 at 21.50 hrs I seized the illegal liquor in presence and duly signed by the witness.

I therefore for pray before your honour to take charge of the seized articles and specific case start against the absconded accused named Santa Mahato (M/55) S/O. Lt. Anjan Mahato of Government Saw Mill Road, Ward No. 04, PS. SLG Dist. under proper section of law.
