Sir,

In producing herewith one accused person named Gagan Roy(40),S/O- Lt. Jageswar Roy of Sishudangi, PO+PS- Matigara, Dist- Darjeeling along with following articles under proper seizure.

- 1] 27 (Twenty Seven) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 7.2 liters, value Rs.120X27=Rs.3240/-), and marked as 'exhibit -A'.
- 2] 01(one) bottle Himalayan Gold 60 UP Country Spirit taken out from exhibit -A as sample for examination and marked as "exhibit A-1".
- 3] 15 (Fifteen) bottles of Kingfisher Strong premium Beer each bottle containing 650ml Total 9.75 Liters, value Rs.130X15=Rs.1950/-), and marked as 'exhibit -B' and
- 2] 01 (one) bottle of Kingfisher Strong premium Beer containing 650ml taken from "Exhibit-B" for examination and marked as "Exhibit-B-1"

I, PSI Shekhar Adhikary presently posted at Matigara Police Station, Siliguri Police Commissionerate would like to lodged this written complaint against the above noted person that today (27.02.2022) at 18.15hrs onwards acting on source information, myself along with, C/986 Kanak Roy and CV-155 Sukumar Das had been to Matigara Sishudangi area and found that the aforesaid person had been selling illegal liquor to the common customers at his house at Sishudangi under Matigara PS. Then I cordoned the place with my accompanied force and detained the person who on being asked disclosed his identity as noted above and stated that he used to sell illegal liquor at this place for his wrongful gain. On being search of him in presence of available witnesses the above noted seized articles are found inside a bag from his conscious possession. On being asked he failed to produce any valid license/papers for selling and storing of such articles. Then I seized the above mentioned articles under proper seizure list in presence of available witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned person. While on the time of cordoning off the place, the persons who were having liquor at that place manage to flee from the spot. On further interrogation of the arrested person it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made in between 19.15hrs. to 20.05hrs.

Therefore, I pray before your good self that a specific case against the above noted accused person named Gagan Roy(40),S/O- Lt. Jageswar Roy of Sishudangi, PO+PS- Matigara, Dist- Darjeeling may kindly be initiated under proper section of law and may cause for its investigation.
