I, ASI Tapan Das of Matigara Police Station here by lodge a written complainant against the above noted accused persons to the effect that today on 27.02.2022 at 18.35 hrs.. onwards while myself along with other officers and force performing lock down duty around City Centre area under Matigara PS found the above noted accused persons were loitering around City Centre area without wearing mask and also not maintaining social distance violating Govt. Order vide order No.753/XVII-ISS/2M-22/2020, dated-02.01.2022. Accordingly, I warned them to obey the Govt. order regarding COVID-19 but they did not pay heed to my words and strongly opposed my lawful direction. Accordingly, I arrested all of them namely i) Debanand Sashani(29), ii) Rajesh Saha(38), iii) Bapi Nandi(26), iv) Sanjeev Thapa(32) and v) Rajat Roy(21), U/S-41 Cr.PC. after observing all formalities

Therefore, I pray before your kind honour that a specific case may kindly started against the accused persons i) Debanand Sashani(29), S/O-Laldeb Sahani of Gurung Busty, Ward No.03, PO+PS- Pradhannagar, Dist- Darjeeling. ii) Rajesh Saha(38), S/O-Lt. Sukumar Saha of Matigara Bhangapool, P.O+P.S- Matigara, Dist- Darjeeling, iii) Bapi Nandi(26), S/O- Basudeb Nandi of Diesel Colony, PO+P.S- Pradhannagr, Dist.- Darjeeling iv) Sanjeev Thapa(32), S/O- Shibu Thapa of Dagapur, Bhandrijote, PO+P.S- Pradhannagr, Dist.- Darjeeling v) Rajat Roy(21), S/O- Pradip Roy of Prodhan More, Ektiashal, PO- Sevok Road, P.S- Bhaktinagar, Dist.- Jalpaiguri under proper section of law and arrange for its investigation.
