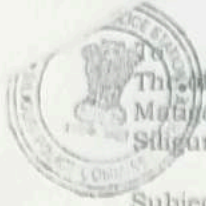

I, SI Krishna Ch. Mandal of Matigara PS SPC to the effect that on 27.02.2022 while performing SPL Mobile duty under Matigara PS area found five persons namely (i) Abhijit Paul (32), S/O Dilip Paul of New Paulpara, PS-MTG, Dist- DJG, (ii) Gulam Rabbani (20), S/O Md. Ismail of Panashi Hut, PS- Islampur, Dist- U/Dinajpur, (iii) Md. Wasiaktar (24), S/O Lt. Saidur Rahaman of Islampur, PS- Islampur, Dist- U/Dinajpur, (iv) Nittu Tamang (31), W/O Lt. Ismail of Panashi Hut, PS- Islampur, Dist- U/Dinajpur, (iii) Md. Wasiaktar (24), S/O Lt. Saidur Rahaman of Islampur, PS- Islampur, Dist- U/Dinajpur, (iv) Nittu Tamang (31), W/O Lt. Narden Tamang of Gurung Busty, PS-Pradhan Nagar, Dist- DJG, (v) Nijamuddin (19), S/O Basiruddin of Lelin Colony, PS-MTG, Dist- Darjeeling under proper section of law and arrange for its investigation.
