Sir,

I, the undersigned, inform you as follows:

1. That on March 30th 2021 I as a customer booked and placed order before abovenamed Sri Tridip Bose who is the Representative of TATA Company for supplying me steel rods and installing two windows and two doors (TATA PRABESH) in my house, and in pursuance of said booking I initially paid him Rs 41,000/- in cash on the even date.
2. That thereafter, on the plea of scarcity of production during pandemic phase, abovenamed Sri Tridip Bose started to defer in providing rods and installing said two windows and two doors in my house, but by inducing me continued to take from me time to time, in his name, further sum of Rs 42,640/- vide cheque No. 372554 dated 10.12.2021 and also sum of Rs 20,000/- vide cheque No. 372558/- dated 22.12.2021, all drawn on Punjab National Bank, Hill Cart Road Branch, Siliguri.
Be it mentioned herein that Sri Tridip Bose abovenamed, duly encashed both of my above referred cheques.
3. That subsequently also when I requested Sri Tridip Bose abovenamed to provide me the steel rods and install the said two windows and doors in my house, Sri Tridip Bose abovenamed, by giving lame excuses postponed the said supply and thereafter assured me to provide rods and install the said two windows and doors in my house from his end within second week of February, 2022 without fail, but till date he with malafide intention neither provided me with

- the steel rods nor installed the said two windows and doors in my house despite payment of entire amount to him from my end totalling a sum of Rs 1,03,640/-.
4. That on recent enquiry from the authorities of TATA Company I came to learn that said Sri Tridip Bose deposited with TATA company only a sum of Rs 20,000/- under my head, out of my said entire payment of Rs 1,03,640/-.
 5. That it has also been learnt that Sri Tridip Bose abovenamed has committed similar kind of fraud upon other customers as well.
 6. That I am unable to trace said Sri Tridip Bose at present, who is guilty of violating the trust I reposed upon him and who intentionally cheated me since inception and misappropriated my money for his illegal gain, causing immense loss and injury to me.

In the above circumstances, I most humbly request you to take appropriate legal action against abovenamed Sri Tridip Bose according to law and save me from suffering further wrongful loss.
