One transparent plastic pouch containing 600 grams (approx) said to be Brown Sugar recovered from the possession of Masidur Rahman which was kept inside the olive green color hand bag wherein written "MARTHA" and marked as Exhibit-A (with pouch), out of which 20 grms. taken as sample and marked as Exhibit -A.1. ii) One transparent plastic pouch containing 500 grams (approx) said to be Brown Sugar recovered from the possession of Ansa Khatun which was kept inside the Rose wood plank color hand bag and marked as Exhibit-B (with pouch), out of which 20 grms. taken as sample and marked as Exhibit -B.1. iii) Cash Rupees 3(three) Lakhs recovered from the possession of Masidur Rahman which were kept inside the olive green colour bag wherein written "MARTHA" and marked as "Exhibit-C. iv) One Carbon blue MI 5G Android Mobile Phone which recovered from the possession of Masidur Rahman in which inserted Vodafone SIM card in its SIM slot having no- 8906666837 and marked as "Exhibit-D". v) One black colour Oppo Smart Phone which recovered from the possession of Ansa Khatun in which inserted Vodafone 5131 card in its Sim slot having no- 9547985402 and marked as "Exhibit-E". vi) One blue Colour Samsung dual keypad mobile phone which was recovered from the possession of Masidur Rahman inserted Vodafone SIM card having no- 8693277812 in its SIM slot having no- and marked as "Exhibit-F". vii) One olive Green colour hand bag wherein written "MARTHA" and marked as Exhibit-"G" viii) One rose wood plank color hand bag and marked as Exhibit-"H"



In producing herewith the arrested accused persons namely Masidur Rahaman (28) S/O- Matlur Rahaman of Shershal P.S- Kallachak Dist- Malda (Not verified) and (2) Anra Khatun (35) W/O- Late Hossain Ali of Nandangan] P.S- Islampur Dist- Uttar Dinaj Pur, At present Biswas Colony ,P.S- Matigara Dist- Darjeeling (Not verified) along with the following selzed articles under proper seizure list:-

- (i) One transparent plastic pouch containing 600 grams (approx) said to be Brown Sugar recovered from the possession of Masidur Rahaman which was kept inside the olive green color hand bag wherein written "MARTHA" and marked as Exhibit-A,(with pouch), out of which 20 grms. taken as sample and marked as Exhibit -A-1.
- (ii) One transparent plastic pouch containing 500 grams (approx) said to be Brown Sugar recovered from the possession of Anra Khatun which was kept inside the Rose wood pink color hand bag and marked as Exhibit-B,(with pouch), out of which 20 grms. taken as sample and marked as Exhibit -B -1.
- (iii) Cash Rupees 3(three) Lakhs recovered from the possession of Masidur Rahaman which were kept inside the olive green colour bag wherein written "MARTHA" and marked as "Exhibit-"C.
- (iv) One Carbon blue MI-5G Android Mobile Phone which was recovered from the possession of Masidur Rahaman In which inserted Vodaphone SIM card in its Slim slot having no- 8906666857 and marked as "Exhibit-"D".
- (v) One black colour Oppo Smart Phone which was recovered from the possession of Anra Khatun in which inserted Vodaphone SIM card in its Slim slot having no- 9547985402 and marked as "Exhibit-"E".
- (vi) One blue Colour Samsung duos keypad mobile phone which was recovered from the possession of Masidur Rahaman inserted Vodaphone SIM card in its Slim slot having no- 8695277812 and marked as "Exhibit-"F".
- (vii) One olive Green colour hand bag wherein written "MARTHA" and marked as Exhibit- "G".
- (viii) One rose wood pink color hand bag and marked as Exhibit-"H".

I, LSI Sunanda Sonar of Pradhannagar Police station, Siliguri Police Commissionerate do here by lodge this written complaint against accused persons namely Masidur Rahaman (28) S/O- Matlur Rahaman of Shershal P.S- Kallachak Dist- Malda (Not verified) and (2) Anra Khatun (35) W/O- Late Hossain Ali of Nandangan] P.S- Islam Pur Dist- Uttar Dinaj Pur At present Biswas Colony ,P.S- Matigara Dist- Darjeeling (Not verified) to the effect that today 24/02/2022 at about 14:20 hrs. I received a specific source input that a huge amount of contraband articles is dealing in front of Hasina Lodge near Siliguri Bus Terminus, under PS Pradhannagar. The matter was diarized vld Pradhannagar PS GDE No. - 1282 Dt- 24.02.2022. Accordingly, I informed the matter to the Inspector In Charge, Pradhannagar Police Station in writing a letter to him and expressed the entire information. As per his kind direction myself along with other officers and force named ASI T.K.Ghosh, ASI Debasish Das, CV- Jagadish Biswas, CV-128 Ajay Sahanl of Pradhannagar P.S left for Siliguri Bus Terminus, under PS Pradhannagar by govt.

vehicle having No- WB 74AC 9851 driven by public driver Suraj Routh to verify the veracity of the information vide Pradhannagar PS GDENo-1285 Dt- 24.02.2022 and Issued C.C. No - 821/2022 Date 24/02/2022.

At the time of departure from PS I took all belongings, Govt Issued weight machine etc. At about 14:45 hrs we arrived at Siliguri Bus Terminus and on way to the spot I called two Independent witnesses namely (a) Munna Sekh 254 s/o Anarul Sekh of Champassari, PS Pradhannagar and (b) Manik Das (19) s/o Gopal Das of Panchanan Colony, Ward no- 1, PS Pradhannagar, Darjeeling and disclosed our identity and informed them about the Information in hand and requested them to accompany us in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and as witnesses under relevant provision of law. As Identified by the source we found that one young person wearing Grey Jeans and Bluish colour Jacket along with one Lady wearing Red colour Churider was standing in front of Hasina Lodge, near Siliguri Bus Terminus and they were carrying hand bag and they were transferring something to each other. Which was matched with our information. Accordingly we intercepted both the person and lady who disclosed their identity as noted above.

After disclosing our identity, we detained the above noted person and lady with strong reason to believe that they were illegally possessing brown Sugar in their possession which they were carrying for selling the same to their designed customers for wrongful gain. On being asked they have confessed that they have possessed brown Sugar in their hand bag. I then gave them option in writing whether they wanted to be searched in presence of Executive Magistrate or by any Gazetted Officer. Then they agreed to be searched by one of them. Further I served them a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and the apprehended person and lady to search our Police Party as per provision of law. But they stated that "Apnader tallashi korte habe Na". Accordingly I informed the matter to I/C Pradhannagar PS over phone as per his kind order I informed to Sri Manish Kumar Yadav, ACP West, Siliguri Police Commissionerate today who was detailed as Special Executive Magistrate of Siliguri Police Commissionerate regarding the interception of the accused persons suspected to be possessed of Brown Sugar and requested him to come to the spot and to supervise the search and seizure being a gazette officer. Accordingly at 15:35 hrs Sri Manish Kumar Yadav, ACP West, SPC arrived at the spot and. Accordingly I disclosed his identity as Special Executive Magistrate of Siliguri Police Commissionerate. Then In presence of Sri Manish Kumar Yadav, ACP West, SPC detailed as Special Executive Magistrate and two independent public witnesses searched the detained persons following all formalities keeping their decency and recovered one transparent plastic pouch containing 600 grams said to be Heroin locally called brown Sugar from possession of Masidur Rahaman which was kept inside the olive green color hand bag wherein written "MARTHA" which he was carrying and one transparent plastic pouch containing 500 grams said to be Heroin locally called brown Sugar from possession of Anra Khatun which was kept inside the Rose wood pink color hand bag which she was carrying. On demand in presence of the Gazetted Officer Sri Manish Kumar Yadav, ACP West, SPC they failed to produce any valid document in support of possessing of the brown sugar which they were carrying.

I, accordingly weighted the recovered packet by the weighing instrument and found total 1100 grams of said to be brown sugar in two transparent packet. Out of which 600 grams said to be Heroin locally called brown Sugar was recovered from the possession of Masidur Rahaman which was kept inside the olive green color hand bag wherein written "MARTHA" and 500 grms said to be brown sugar was recovered from possession of Anra Khatun which was kept inside the Rose wood pink color hand bag. Thereafter the said articles marked as Exhibit- A and exhibit-B respectively. I also taken 20 grams of said to be Brown Sugar from the each packet as sample and marked as exhibit A-1 and B-1 respectively. Also recovered cash Rs three(3) lakhs, three Mobile phones from their possessions. I also labeled and sealed all the articles in presence of the Sri Manish Kumar Yadav, ACP West, SPC acting as

Special Executive Magistrate and Independent witnesses and apprehended persons. Then I, seized the above noted articles under proper seizure list and label duly signed by the above noted witnesses and the Gazetted Officer and acknowledged by the accused persons. The seizure was made between 15:50 hrs to 17:10 hrs. On further asked both the apprehend persons confessed in presence of Sri Manish Kumar Yadav, ACP West, SPC acting as Special Executive Magistrate and other witnesses that they failed to produce any documents in r/o brown sugar. The apprehended person stated that he procured the brown sugar clandestinely from Kallachak, Malda for the purpose of supply the same to the apprehended lady and other persons of Silliguri area as per their requirement. Further on Interrogation the apprehended lady stated that she used to purchase Brown sugar from the apprehended person named Masidur Rahaman several time for selling the same in high rate to the students, local people of the local area of Silliguri for her personal gain by illegal means. On interrogation they also disclosed that they have been dealing in such business of selling the brown sugar illegally for last few months.

Then I arrested both the above noted apprehended person and lady after observing all guidelines of Apex court of arrest as well as after disclosing the cause of arrest and issued necessary Memo of Arrest. The whole process of seizure and arrest was made in-between 15:50 hrs to 17:10 hrs. Thus arrested persons namely (Masidur Rahaman (28) S/O- Matiur Rahaman of Shershai P.S- Kaliachak Dist- Malda(Not verified) and (2) Anra Khatun (35) W/O- Late Hossain Ali of Nandanganj P.S- Islam Pur Dist- Uttar Dinaj Pur At present Biswas Colony ,P.S- Matigara Dist- Darjeeling (Not verified) violated the terms and condition of Narcotic Drugs for possessing said to be brown sugar without any valid authority & license.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons named Masidur Rahaman (28) S/O- Matiur Rahaman of Shershai P.S- Kaliachak Dist- Malda(Not verified) and (2) Anra Khatun (35) W/O- Late Hossain Ali of Nandanganj P.S- Islam Pur Dist- Uttar Dinaj Pur At present Biswas Colony ,P.S- Matigara Dist- Darjeeling (Not verified) and arrange for its investigation.
