PS GDE NO .1415 dtd.26.02.22 , I received an information that one person namely Sunil Kumar Lal is storing and selling liquor illegally in his Petty shop at Gate bazar , under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with , CV/992 Jagadish Biswas CV/646 Baban Das rush to the spot and as pointed by the source we apprehended the above noted person and on search his shop ,recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 19.15 hrs to 19.45 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Sunil Kumar Lal (49) S/O Lt. Turapati Lal of Mahananda Colony ,P.S-Pradhannagar,Dist. Darjeeling and arrange for its investigation.
