I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 26.02.22 in course Special mobile van duty at PS area with force vide PDN PS GDE NO .1415 dtd.26.02.22 , I received an information that one person namely Mithu Sah is storing and selling liquor illegally in his Petty shop at Gate bazar ,under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with , CV/128 Ajay Kr Sahani , CV/242 Rakesh Mangar rush to the spot and as pointed by the source we apprehended the above noted person and on search his shop ,recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 23.25 hrs to 23.45 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Mithu Sah (30) S/O Lt. Narayan Sah of BRI Colony ,P.S-Pradhannagar,Dist. Darjeeling and arrange for its investigation.
