We have tried to find the miscreants and the reason behind this incident in nearby areas but we haven't found yet.

There have been quite a number of cases in our surrounding area for the past few weeks. Since it is a matter of our safety, I request to look into this matter and take the necessary action at the earliest. Looking forward to your kind assistance in this matter.

It is prayed that an FIR may kindly be registered and the accused be arrested and brought to the books and tried as per law.


