Sir,

With due respect, in producing herewith the arrested accused namely; (1) Sri. Pintu Prasad (33) S/O Madan Prasad of Himali Sahid Nagar, Near Holi Crown School, Ward No. 43, PS Bhaktinagar, Dist. Jalpaiguri and (2) Hiralal Prasad Roy @ Hira Roy (38) S/O Lt. Ganilal Roy of Prakash Nagar, Near Community Hall, Ward No. 43, PS Bhaktinagar, Dist. Jalpaiguri and would like to lodge a written complaint against them and 4/5 others.

I, SI Dwipendra Nath Bakshi of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodged written complaint that on 28.02.2022 at around 11.05 hrs while performing K-37 I Van duty along with force C/707 Swapan Ghosh and C/1431 Dilip Barman, vide GDE No. 1335 Dated 28.02.2022 and M.C.C. No. 752/2022 Dated 28.02.2022 received an information that some supporters of Bhartiya Janta Party blocked the road at Sahid Nagar More, NH 10. I shared the information with Sri. Amaresh Singh, I.C. Bhaktinagar PS, SPC and he directed me along with force to work out the information. Accordingly, at 11.15 hrs, I along with force had been to Sahid Nagar More, NH 10, PS Bhaktinagar, Dist. Jalpaiguri found above noted accused persons along with others had obstructed the National Highway 10 by sitting in the middle of the road and also tyres were burnt in the middle of the national highway causing injury to the national highway and making it impassable. They were repeatedly directed to lift the blocked but they paid no heed but went on sloganeering against Police and Govt. I along with force proceeded to remove them but they started using criminal force by dashing and pushing to policemen on duty in order to prevent and deter us from discharging our duty and to continue with their illegal act. With no option left, with reinforcement by K-37 Van with officer ASI Asit Saha accompanying LSI Niden Sherpa along with force reached at the spot and proceeded to arrest them, some of them fled away but the above noted two persons could be apprehended and arrested u/s 41 CrPC under proper memo of arrest after explaining the charge against them.


Under the above circumstance, I request you that a specific case may kindly be started against the above noted arrested accused person and others and arranged for proper investigation of the case.
