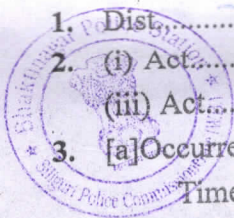

That on 19.01.2022 without any notice to us Maya Rani Sarkar W/O Binoy Kumar Sarkar resident of Kankatta
More, Eastern bypass, Siliguri along with 10 to 12 unknown persons and Revenue Officer from BLRO Rajganj
office tried to illegally enter our above land to conduct field enquiry on protest by us then they went away.

That today we came to know that again about few weeks back Maya Rani Sarkar W/O Binoy Kumar Sarkar
resident of Kankatta More, Eastern bypass, Siliguri along with 10 to 12 unknown persons and Revenue Officer
from BLRO Rajganj office had illegally entered our above land and conducted field enquiry without any notice
to us.

We apprehend that the above Subir Bhattacharjee representative of Maya Rani Sarkar with help of the
unknown land mafias will again try to take forcefull and illegal possession of our above land
We would request your kind action the matter so that our peacefull possession of land is not disturbed.
