I Sikha Chatterjee, MLA Dabgram, Fulbari  
Constituency, would like to bring this into  
Your kind notice that today, I along with other  
Karyakartas, were protesting against the  
Poll day violence in the Municipal Corporation  
and Panchayat election throughout the state  
of West Bengal, when some TMC goons lead  
by one Munna Prasad, Ward councillor of  
Ward no. 40 and Sukdeo Mahata Ward Councill  
-or of Ward no. 43 along with <sup>Laxpy</sup> <sup>James</sup> their  
henchmen arrived at the Checkpost area
