I the undersigned would like to inform you that I have lodged a written complaint to you on 19.10.2019 against one Tapan Kumar Poddar, S/o. Late Amulya Poddar, Sri Anupam Mitra, S/o. Late Amal Kumar Mitra and others and on the basis of my said complaint one specific case has been registered by you being Bhaktinagar P.S. Case No: 824 dated 19.10.2019 under section 447, 427, 506 & 34 of I.P.C. (Photocopy of the F.I.R. and written complaint dated 19.10.2019 is annexed herewith for your kind perusal).


I would further like to inform you that after registration of the said case, the above noted persons along with their associates fled away from my land and till that day the said land has remained vacant and with the intervention of the investigating officer, I put the pad lock at the main entrance of the said land.

I would further like to inform you that today I found that someone has made a small temporary structure/ room by using and processing bamboos, ropes and CI sheets in and over my said land and it was very obvious to understand and learn clearly that even though the main entrance is locked and keyed, the persons who entered into my said land for making the said structure, had entered using the very land and passage of Sri Anupam Mitra who is one of the accused persons of the said criminal case and it is my serious apprehension that the said Anupam Mitra has certainly and obviously engaged his men and persons for making the said illegal structure with a clear intension to occupy and grab my land.


