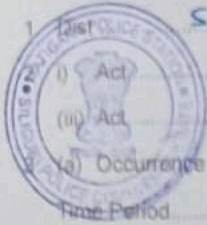

Subject: FIR

Sir,

In producing herewith one arrested accused person namely Dinabandhu Barman(28) S/O Dilip Barman of Goyeljote, P.O- Nemai, P.S- Matigara, Dist.- Darjeeling along with one seized vehicle bearing no- WB- 76 A 9340 (Dumper truck) loaded with river bed materials under proper seizure.

I, PSI Newton Biswas of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against one namely Dinabandhu Barman (28) S/O Dilip Barman of Goyeljote, P.O- Nemai, P.S- Matigara, Dist.- Darjeeling the driver of Seized vehicle bearing no- WB- 76 A 9340 (Dumper truck) loaded with river bed materials to the effect that today on 03.03.2022 at 03.45 hrs. received a specific source information that one vehicle bearing no- WB- 76 A 9340 (Dumper) loaded with river bed materials had been moving along the road from Bansbari Ghat towards Himul last gate, under Matigara P.S. Accordingly I informed the matter to the O/C PS and being directed by the O/C PS myself along with assisting force left PS to verify the veracity of source information. On the way at Himul Last gate, under Matigara P.S, I detained a vehicle bearing no- WB- 76 A 9340 (Dumper) loaded with river bed materials and also apprehended the driver of the said vehicle who on being asked disclosed his identity as Dinabandhu Barman (28) S/O Dilip Barman of Goyeljote, P.O- Nemai, P.S- Matigara, Dist.- Darjeeling. On demanded he failed to produce any valid documents/papers for carrying the river bed materials. On being further interrogation the driver of the vehicle bearing no- WB- 76 A 9340 (Dumper truck) stated that he, without the knowledge of the owner of vehicle bearing no- WB- 76 A 9340 (Dumper truck) is carrying river bed materials by illegal means for his wrongful gain since last few months. Accordingly I seized the vehicle bearing no- WB- 76 A 9340 (Dumper truck) being loaded with river bed materials and subsequently arrested the driver named Dinabandhu Barman (28) S/O Dilip Barman of Goyeljote, P.O- Nemai, P.S- Matigara, Dist.- Darjeeling. The whole process of seizure and arrest was made in between 04.45 hrs. to 05.25 hrs.

Hence, I pray that a specific case may kindly be started against the driver namely Dinabandhu Barman (28) S/O Dilip Barman of Goyeljote, P.O- Nemai, P.S- Matigara, Dist.- Darjeeling loaded with river bed materials under proper section of Law and arrange for its investigation.
