Recently I came to know that three (3) new Facebook account again been opened in my name with my photos posted in the wall of the Facebook. The details of all the fake facebook accounts has been attached herewith in the Complaint. Finding no other option I came before you for justice.

It is requested before you to kindly take necessary action against the persons involved so that he can be punished for the wrongful act & the fake facebook accounts can also be closed immediately.
