In producing herewith the following seized articles such as; 1] One iron made improvised firearm seemed 7 MM pistol measuring approx 16 CM (Diagonally measured) having trigger, magazine, butt barrel with inscription "AUTOMATIC PISTAL MADE IN U.S.A". 2] One black coloured imitation of Pistol, which is used as fire lighter measuring approx 20 CM (Diagonally measured), having inscribed "XIN.SHI.JI.MADE.IN.JIAN.CHEN (JC) MADEINCHINA" both wrapped in red coloured having white print piece of cloth, which was recovered from room of Biplab Sarkar @ Kangaroo S/o Lt Bipat Bhajan Sarkar of Janata Nagar, PS Bhaktinagar, Dist: Jalpaiguri, under his bed & in the rented house of Swapan Das, under proper seizure list.

I, ASI Rabin Lama of Bhaktinagar PS, SPC do hereby lodge a complaint against the above noted accused Biplab Sarkar @ Kangaroo S/o Lt Bipat Bhajan Sarkar of Janata Nagar, PS Bhaktinagar, Dist: Jalpaiguri to the effect that on 01.03.2022 one known person but who did not want to disclose his identity informed us that one Biplab Sarkar @ Kangaroo of Janata Nagar, under Bhaktinagar PS, Dist: Jalpaiguri is roaming at around the locality and he is showing small arms with a view to commit crime in Bhaktinagar area and accordingly engaged sources to verify the veracity of the information. After getting information from the source that Biplab Sarkar @ Kangaroo possess genuine arms, I noted all the facts was diarized vide Bhaktinagar PS GDE No-49 dated 01.03.2022 at 23:05 hrs and I shared the information with I.C. PS, and as per the direction of I.C Bhaktinagar PS, myself along with LC 1248 Pooja Tamang, C/374 Debraj Biswas, C/762 Mojibul Rahaman rushed to the spot to work out the information vide GDE No-50 dt. 01/03/22 at about 23.15 hrs we reached at Janata Nagar, Sevoke Road, under Bhaktinagar PS. As there was reason to believe that a search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender, then I called upon disinterested witnesses namely- 1) Swapan Das (58) S/o Lt Kiran Das of Janata Nagar, Ward No 44, PS Bhaktinagar, Dist: Jalpaiguri 2] Sanjit Debnath @ Jhingur S/O Lt Narugopal Debnath of Do and on request, they accompanied us during the whole raid session and we also requested them to search the persons of each police personnel in our team and nothing could be found except service fire arms and wearing apparels. There after we along with the disinterested witnesses entered


in to the rented house of Biplab Sarkar @ Kangaroo. During raid, Smt. Pratima Sarkar, mother of suspected person Biplab Sarkar @ Kangaroo opened the door and asked her about her son. She stated that her son did not come home since morning when he left for Mandir. I also enquired about any arms and ammunitions as per information but she stated that she had no information that her son possessing arms and ammunitions. However, with a strong reason to believe and with due permission from her, searched Biplab Sarkar @ Kangaroo's bed room but Biplab Sarkar @ Kangaroo could not be found. Further searched his room and under his bed, in presence of the house owner and mother of kangaroo and in presence of disinterested witnesses, I recovered 1] One iron made improvised firearm seemed 7 MM pistol measuring approx 16 CM (Diagonally measured) having trigger, magazine, butt barrel with inscription "AUTOMATIC PISTOL MAD IN U.S.A." 2] One black imitation of Pistol, which is used as fire lighter measuring approx 20 CM (Diagonally measured), having inscribed "XIN.SHI.JI.MADE.IN.JIAN.CHEN (JC) MADE IN CHINA" which was kept concealed under the bed of Biplab Sarkar @ Kangaroo. Further interrogation mother of Biplab Sarkar @ Kangaroo disclosed that the room where search was made belonged to her son Biplab Sarkar @ Kangaroo and had no knowledge about the fire arms recovered from her son Biplab Sarkar @ Kangaroo's room. During enquiry, it could be learnt that the accused Biplab Sarkar @ Kangaroo is a veteran criminal of this area and he used to carry this arms without any valid documents for the purpose of committing the crime. Earlier also he had been arrested with illegal fire arms under Panitaki TOP area, under Siliguri PS and a specific case had been registered against him and his associates. Hence the accused Biplab Sarkar @ Kangaroo S/o Lt Bipat Bhajan Sarkar of Janata Nagar, PS Bhaktinagar, Dist: Jalpaiguri violated the provision of Arms Act. Accordingly, I seized the same under proper seizure list in presence of his mother, house owner and witnesses and label the same. Seizure and labelling was made in between 00.35 hrs to 01:05 hrs on 02.03.2022.

Under the above, I pray that a specific case under proper section of law may kindly be started against accused persons Biplab Sarkar @ Kangaroo S/o Lt Bipat Bhajan Sarkar of Janata Nagar, PS Bhaktinagar, Dist: Jalpaiguri and arrange for its investigation.
