③ Santosh Kumar Paswan (choto) s/o Joginder Paswan  
④ Smt Madhu Paswan w/o Bikky Paswan ⑤ Menmom  
Paswan and more 25 to 30 people (all residents of  
Surya Sen Colony, NTP) started pushing and fighting  
~~menom~~ with all of our family member. They started  
fighting and abusing us they were threatening that they  
would kill us. They pushed my daughter and Santosh Kumar  
Paswan and Bikky Paswan tried to molest my daughter  
Amrita Kumari Ram. They attacked us very badly.

I therefore request you to kindly investigate the  
case and take necessary action
