In producing herewith the following accused namely 1) Gopal Saha (M/29) S/O. Lt. Swapan Saha of Purba Dhantala, PS. NJP Dist. JPG. 2) Raja Basfore (M/27) S/O. Dinesh Basfor of Tikia Para Ward No. 28 PS. SLG Dist. DJG. 3) Raju Sahu (M/28) S/O. Deben Sahu of Ghoghomali Niranjan Nagar at State bank Gali, PS. BKN Dist. JPG. 4) Sanjay Sutradhar (M/21) S/O. Lt. Santosh Sutradhar of kali Saha More near Sabita Bhawan, Ashighar PS. BKN Dist. BKN in custody along with the following seized articles Viz:-

 One Iron Made Sabol generally used for house breaking length approx 36" (inch) feet long from the Possession of Gopal Saha

ii) ONE Ram daw (Chopper) made of iron with a wooden handle bar, total length approx 24" (inch) including handle from the possession of Raja Basfore . .

(iii) One iron made Knife length approx 07 inch and butt approx 03 inch from the possession of Raju Sahu.

iv) One iron made Knife length approx 07 inch and butt approx 03 inch from the possession of Sanjay Sutradhar.

I, ASI. Md Jinnat Ali of Khalpara TOP, SLG. P.S, SPC, would like to lodge this written complaint against the above noted persons and also 2-3 other absconded persons to the effect that today i.e on 02/03/22 at about 12.30 hours during my night K-27 Patrolling van duty along with C/390. Sujit Paul and CV/980. Amaresh Singh Vide Khalpara TOP GDE No. 40 Dt. 02/03/22 received a secret source information that a group of 05-06 persons have assembled at Adarsha Nagar Math Ward No. 04 under SLG PS. with deadly weapons with a view to commit some heinous crime. Accordingly without wasting any time I informed the matter to 0/C Khalpara TOP and as per instruction of 0/C Khalpara TOP. I along with C/390. Sujit Pal and CV/916. Amaresh Singh of Khalpara left for Adarsha Nagar Math to check out the veracity of the information and to work upon it. We reached near the spot as directed by the source at about 12.55 hours and stopped at a considerable distance from the above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement.

We reached at Adarsha Nagar Math near Sabji market at about 01.05 hrs and found a group of 05/06 persons sitting at the darkest corner of Adarsha Nagar math Ward No. 04. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away, Anyhow, after a hot chase we could able to apprehend the 04 (Four) above referred accused persons. After apprehension the 04 persons disclosed their identity as noted above and also stated that there were 2/3 other persons with them and they were un-identified and brought on hire. They were planning to commit a Dacoity at the house of a local businessman. Thereafter all the apprehended persons were searched

in presence of the Police witnesses as in that late hours I could not found any independent witnesses at the area and the above noted articles were seized.

Thereafter all the articles were seized in-between 01.25 hrs to 01.40 hrs. issuing a proper seizure list duly signed by the witnesses and the accused persons. Thereafter all the persons were arrested accordingly as they were assembled for committing a heinous crime.

On the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the 04(FOUR) arrested persons namely 1) Gopal Saha (M/29) S/O. Lt. Swapan Saha of Purba Dhantala, PS. NJP Dist. JPG. 2) Raja Basfore (M/27) S/O. Dinesh Basfor of Tikia Para Ward No. 28 PS. SLG Dist. DJG. 3) Raju Sahu (M/28) S/O. Deben Sahu of Ghoghomali Niranjan Nagar at State bank Gali, PS. BKN Dist. JPG. 4) Sanjay Sutradhar (M/21) S/O. Lt. Santosh Sutradhar of kali Saha More near Sabita Bhawan, Ashighar PS. BKN Dist. BKN and 2-3 others unidentified persons assembled with deadly weapons to commit a heinous Crime.
