In producing here with the accused person namely Rina Mahato (35/F) W/O Ashok Mahato of Santoshi Nagar, ward no-05, PS- Siliguri, Dist- Darjeeling along with seized 10 (Ten) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 120/-in each bottle i.e. total amount of Rs- 1200/- (Rs/- One thousand two hundred only) in which 01 (one) bottle taken as sample and marked as Exhibit-"A-1".

I ASI Aminul Islam of Khalpara TOP under PS Siliguri beg to report that today i.e. on 05.03.22 while performing special mobile van at 14:20 hrs I received a source information that one person lady namely Rina Mahato (35/F) W/O Ashok Mahato of Santoshi Nagar, ward no-05, PS- Siliguri, Dist- Darjeeling is selling huge alcohol at Santoshi Nagar, ward No.05 under Khalpara TOP without any valid license and documents in higher price than the actual value for her illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force with lady constable 1216 Pushpanjali Yanzon left for Sontashinagar under Khalpara, Siliguri to verify the veracity of the information vide Khalpara TOP GDE No -105, Dated: 05.03.22. After reaching Santoshinagar at 15:25 hrs and as shown by the source I found the above noted lady person is selling liquor secretly to different persons and seeing the Police party the above noted person try to flee away but lady constable managed to intercept him. On being asked she disclosed her identity as mentioned above. During search, I could recover the above noted alcohol from his house. During interrogation in present of lady force she admitted that she is selling alcohol for her wrongful gain. On demand she failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long. Accordingly, I seized the above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labelled in presence of witnesses and took their signature in the seizure list and labels and also aprehanded the above noted accused person U/S-41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 15:45 hrs to 16:20 hrs on 05.03,22.
