In producing here with the accused person namely Suraj Gupta (42/M) S/O Late Mohan Gupta of Swaminagar Coloney, Vivekananda road, ward no-07, PS- Siliguri, Dist-Darjeeling along with seized 11 (eleven) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 120/-in each bottle i.e. total amount of Rs- 1320/- (Rs/- One thousand three hundred twenty only) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1".

I PSI Phurba Tendu Sherpa of Khalpara TOP under PS Siliguri beg to report that today i.e. on 05.03.22 while performing special mobile van at 14:55 hrs I received a source information that one person namely Suraj Gupta (42/M) S/O Late Mohan Gupta of Swaminagar Coloney, Vivekananda road, ward no-07, PS- Siliguri, Dist- Darjeeling is selling huge alcohol at Vivekananda road near red light area under Khalpara TOP without any valid license and documents in higher price than the actual value for his illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for Vivekananda road, near red light area Khalpara Siliguri to verify the veracity of the information vide Khalpara TOP GDE No -101, Dated: 05.03.22. After reaching Vivekananda road at 15:15 hrs and as shown by the source I found the above noted person is selling liquor secretly to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept him. On being asked he disclosed his identity as mentioned above. During search, I could recover the above noted alcohol from his possession. During interrogation he admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long.
