Respected Sir,

With due respect, I, **SRI KUMAR MANISH**, Son of Shyam Bahadur, Resident of D/4, Vrindraban Greens, Opp. Sona Petrol Pump, Nirmala Convent Road, P.O. & P.S. Bhaktinagar, Dist. Jalpaiguri, Pin: 734007, would like to lodge this written complaint to the effect that I am an employee of Union Bank of India, Durgapur Regional Office as a Assistant Manager and considering my said service, I have been residing at Durgapur. Sir, my wife **SMT. JANUKA DEVI** is also an employee of SBI Life Insurance and presently she is posted at Salugara Branch, Siliguri as a Territory Manager. Sir, on 27.02.2022 at about 12.30 P.M., my wife left our house with my Scooty Vehicle being No. WB74-BJ1357 (Suzuki Access 125) in order to visit at City Centre, Siliguri and at about 12.45 P.M., when she reached at Champasari Traffic Point, Under Pradhan Nagar Police Station, at that relevant point of time, one Bolero Pick Up vehicle bearing Registration No. **WB-73-F-1542**, which was coming from the back side of my wife with a very high speed and negligent manner and subsequently hit and dashed my vehicle forcefully for which, my wife has fallen down on road and received severe injury on her person and due to the said accident, the right hand of my wife has totally fractured and immediately after the said incident, some local people gathered there and recovered my wife and took her at North Bengal Medica, Siliguri in a critical condition and still now, she is undergoing treatment at North Bengal Medica. Sir, the local peoples who saw the said incident in their own eyes, told me that the said accident occurred due to the rash and negligent driving of the driver of the said offending pick up vehicle vide Registration No. **WB-73-F-1542**. Sir, as we were remains busy considering the health condition of my wife and also for the purpose of her treatment, some delay has been caused for lodging this written complaint and the same may be condoned.

I, therefore, request you to kindly investigate into the matter properly and please take necessary legal action against the driver of the said offending vehicle vide Registration No. **WB-73-F-1542** as per the provisions of law and obliged thereby.
