With due respect and humble submission, in producing herewith one accused namely Manoj Paswan(38) S/o Lachhmi Paswan of Kolabari, PS Pradhan Nagar Dist Darjeeling under arrest along with following articles under proper seizure ;

- i)12(Twelve) glass bottles of King Fisher Strong Beer each contains 650 ML.
- ii) 08(Eight) glass bottles of Officer Choice Blue Grain whisky each bottle contains 375 ml.

I ASI Debasish Das of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 05.03.2022 in course Special drive duty at PS area with, I received an information that one person is storing and selling liquor illegally from his house at Kolabari under Pradhannagar PS. Accordingly, I share the information to you and as per your kind instruction myself along with , CV/242 Rakesh Mangar, CV/992 Jagadish Biswas left PS vide Pradhan Nagar PS GDE No-258 dated 05.03.2022 and rush to the spot and as pointed by the source we held raid at the house and apprehended the above noted person and on search of his house recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 19:45 hrs to 20:35 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person Manoj Paswan(38) S/o Lachhmi Paswan of Kolabari, PS Pradhan Nagar Dist Darjeeling and arrange for its investigation.
