With due respect ,I, **Sri Uttam Thapa**, Son of Prem Bahadur Thapa, resident of ,Salbari, P.S. Matigara, Dt. Darjeeling, would like to inform you that my grandfather namely Late Nandalal Thapa was the sole absolute and owner in possession of total land measuring about 26 decimal at Dhukuria mouza in plot no 108 (11 decimal) and 109 (15 decimal) respectively described in the schedule below. Since the date of purchase my grandfather during his lifetime was cultivated the land without any interruption or any hindrance. Very recent in plot no 109 the local (1) **Sri Suga Oraon**, Son of Late **Bhagnu Oraon**, (2) **Smt Baingai Oraon**, Wife of **Atoa Oraon**, (3) **Smt Gandhari Oraon**, Daughter of **Chhuri Oraon** starting disturbance for their wrongful gain. Yesterday the above mentioned miscreants with their men were appeared before my land in plot no. 109 and tried to erect bamboo fencing when we have informed instantly appeared there and requested them not to do such illegal work that time they used filthy languages to us and also said by way of any means they will captured our land. From our strong objection they have leaved the place immediately.


In this above circumstances I am requesting you to kindly investigate the above-said matter and take appropriate step against the abovesaid land grabbers and thus kind oblige me.
