Sir,

In producing here with the one arrested accused person namely Bidyanand Mahato (48) s/o Gurakh Mahato of Prakashnagar, Sahani Basty, Ward No. 43, PS Bhaktinagar, Dist Jalpaiguri alongwith the following seized articles as per proper seizure list:

- 1] Twenty Four Bottles of Royal Blue Premium Whisky each Bottle containing 375 ml.
- 2] Eighteen Bottles of Royal Blue Premium Whisky each Bottle containing 180 ml.

I, PSI Sailesh Subba of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 05.03.2022 while performing special raid duty under Bhaktinagar PS area vide BKN PS GDE No.219, Dated. 05.03.2022 at about 13.20 Hrs I, received a source information that the above noted accused person has possessed huge amount of Liquor at his shop cum house for the purpose of selling the same to local customers. Accordingly the information shared before you and as per your kind direction I along with ASI Dipak Karmakar, Constable C/762 Debraj Biswas, CVF-014 Labanyamoy Barman headed towards Prakash nagar to verify the veracity of the information. At about 13.45 Hrs we reached at Prakash nagar and as shown and being identified by the source held raid and apprehended one person who disclosed his identity as noted above. Further maintaining his decency and observing all formalities searched his shop and house and recovered huge amount of above noted seized liquor from his house. On demand he could not produce any valid documents/licence in respect of the recovered liquor. On enquiry the apprehended person admitted his guilt and confessed that he has possessed above noted liquor at his house for the purpose of selling to his designed customers. He also stated that he has been doing this illegally since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 14.05 Hrs to 14.35 Hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Bidyanand Mahato (48) s/o Gurakh Mahato of Prakashnagar, Sahani Basty, Ward No. 43, PS Bhaktinagar, Dist Jalpaiguri under proper section of law and arrange for its investigation.
