In producing here with the one accused person namely Vijay Sharma (41) s/o Late Ram Prasad Sharma of North Ektiasal, Khudiram Pally, Near Himalayan English School, PS Bhaktinagar, Dist. Jalpaiguri along with following seized articles as per proper seizure list:

1] Twenty Three (23) Bottles of Royal Star Golden Brandy each Bottle containing 750 ml. Blended and Bottled by Mount Distillers Ltd. Mazitar, Rangpo, Sikkim

2] One Purple and Black coloured Duffle Bag (in which the above noted articles was kept).

I, ASI Rabin Lama of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person to the effect that on 05.03.2022 while performing Special raid duty vide Bhaktinagar PS GDE No. 219, Dated. 05.03.2022 at around 15.25 hrs received a source information from my source that one person namely Vijay Sharma has stored huge quantity of liquor illegally in his furniture shop named and styled as "AMBA TRADERS" situated at North Ektiasal, Khudiram Pally, Near Himalayan English School under Bhaktinagar PS. Accordingly the information shared before you and as per your kind direction I along with Constable C/762 Mujibul Rahaman, CVF-614 Sumit Kumar Roy of Bhaktinagar PS/SPC left towards North Ektiasal to verify the veracity of information. At around 15.45 Hrs we reached at the noted place and being shown and identified by the source I along with force intercepted the aforesaid person namely Vijay Sharma. To verify the source information I enquire the matter to him but he clearly denied about such information. Further, after maintaining his decency and on his consent I, along with force searched inside the shop and found One Purple and Black coloured Duffle Bag kept in conceal position inside the room of the shop. On being search of the bag I recovered Twenty Three (23) Bottles of Royal Star Golden Brandy each Bottle containing 750 ml. Blended and Bottled by Mount Distillers Ltd. Mazitar, Rangpo , Sikkim. On demand he could not produce any valid documents/license in respect of the said liquor. Further on enquiry the above noted person admitted his guilt and confessed that he has been storing the liquor illegally after procuring the same from Sikkim for the purpose of selling to the local customer without any valid licence or Documents for his wrongful gain. Accordingly, I packed labelled and seized all the recovered liquor in presence of witnesses duly sign by them as well as accused person. The labelling and seizure was made in between 15.55 Hrs to 16.25 Hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the accused person namely Vijay Sharma (41) s/o Late Ram Prasad Sharma of North Ektiasal, Khudiram Pally, Near Himalayan English School, PS Bhaktinagar, Dist. Jalpaiguri u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Vijay Sharma (41) s/o Late Ram Prasad Sharma of North Ektiasal, Khudiram Pally, Near Himalayan English School, PS Bhaktinagar, Dist. Jalpaiguri under proper section of law and arrange for its investigation.
